This application is for the Herbert and Vivian Lionberger Scholarship Fund, the Charles M. Hudson Memorial Scholarship Fund, the Ralph H. and Jean M. Luebbers Scholarship Fund and the Keeper's Scholarship Fund. The Scholarship committee has adopted a common application so that applicants can be considered for all scholarships for which they are eligible.

Each scholarship has a particular focus. Their specifics are as follows:

The Lionberger Scholarship Fund is to assist students pursuing higher education for careers in the helping sciences.

The Hudson Memorial Scholarship Fund is to assist students pursuing higher education in general.

The Luebbers Scholarship Fund is to assist students pursuing higher education in the sciences and engineering.

The Keeper's Scholarship Fund is to assist women pursuing higher education in ministry.

In all cases, the criteria for selection is based on scholarship, citizenship and financial need of the applicant. Preference will be given to an applicant where either the applicant or members of the applicant's family or ancestors have considered the First Baptist Church of Columbia, Missouri as their church home. However, the Scholarship Committee will consider applicants from other churches and denominations. It is the committee's intention to award these scholarships to as many different students as possible; therefore, consideration will be given to those who have not previously received the award.
